Budget Agreement Update-There was a discussion about the confusion between the joint Budget Agreement between the City and the District. Shawn Brazil moved that Jordan Weddle and David Stangland will work with our Legal Representative Megan Kernan to adjust the City's draft Budget Agreement and create a final version of a joint budget between the City and the District that can be taken to the City Council for approval. Billie Attwood seconded the motion. The motion passed with a unanimous vote. The Board would like to add some language about the Facilities Grant Program, how the revenue of the pool must be used only for the pool expenditures, and the reason the Parks and Recreation District was created. The board discussed the options for processes for taking care of expenditures and to ensuring the City receives District funds in a timely fashion.

New Business

Proposed Addendum to the Interlocal Agreement by the City-David Stangland and Jordan Weddle reported information about the proposed addendum to the Interlocal Agreement by the City. The board discussed some joint revisions. Shawn Brazil moved that Jordan Weddle and David Stangland discuss the proposed joint revisions with our Legal Representative Megan Kernan and create a final version of an addendum to the Interlocal Agreement with the City. David Stangland seconded the motion. The motion passed with a unanimous vote.

Enduris Insurance-Billie Attwood reviewed and recommended an explanation of the insurance that Enduris offers to cover our personal liabilities. Enduris is a local government entity. The annual estimated cost for this insurance is \$2691 about 5% of our annual revenue. Billie Attwood will look into another option to bring to the next meeting.

*Timeline for appointments, elections and how membership might change this year-*The board discussed timelines and procedures for the election of new board members and how board members might be appointed after a resignation of a member of the Tonasket Parks and Recreation Board.

Adjournment- Shawn Brazil moved to adjourn at 10:02 p.m. Billie Attwood seconded the motion. The motion passed with a unanimous vote.
