## Unfinished business

**Budget Agreement Update-**The Board reviewed the May draft of the Annual Budget Agreement between the City of Tonasket and the Tonasket Parks and Recreation District. The motion passed with a unanimous vote.

**Timeline for appointments, elections, and membership-**Kathleen Thompson officially resigned her Position #1 of Tonasket Parks and Recreation Board Commissioner as of May 10, 2017. Rick Massey is interested in becoming a commissioner and Tyler Graves is still undecided at this point. The Board will talk about potential future Board appointments at the next meeting.

Enduris Insurance-Billie Attwood reviewed and recommended an explanation of the insurance that Enduris offers to cover our personal liabilities. The Tonasket Swimming Pool Association pays \$4135 with VIP Agency because they act as general contractors. The other quote from GSU Insurance Services was \$853, but this is only for Errors and Omissions and Directors and Officers. The Board would have to get other insurance to be covered for liability. Kathleen Thompson moved to purchase Enduris Insurance for the Tonasket Parks and Recreation Board, if it is discovered that it could be a sole-source contract or falls under our rules for procurement. Billie Attwood seconded the motion. The motion passed with a unanimous vote.

**State Auditor's Annual Report-**Along with the annual report to the State Auditor, Jordan will send a signed copy of the Interlocal Agreement with the City, the Annual Budget agreement between the City of Tonasket and the Tonasket Parks and Recreation District.

**Process for making payments to the City**-Jordan talked with Cari Hall at the county about how the process for making payments to the City is going to work. The State Auditor's office will help us figure out how to get started with paying for the lifeguard uniforms and training.

**Public Records Officer**-Billie Attwood has volunteered to fill Kathleen Thompson's position. Shawn Brazil moved to make Billie Attwood the new public records officer. Kathleen Thompson seconded the motion. Kathleen Thompson will amend the public records policy with the new contact information.

**Amendment to the Interlocal Agreement-**The Board will table the amendment discussion until our legal counsel can look at the language.

**Adjournment-** Shawn Brazil moved to adjourn at 8:25 p.m. Billie Attwood seconded the motion. The motion passed with a unanimous vote.
