- Dave moved to approve last months minutes. Billie seconded. Minutes passed unanimously.

Documents from the county treasure reflecting cash on hand show an ending balance of \$71,712.36. End balance may not reflect the previous two months of expenditures.

## **Agenda**

#### Old Business

- Tax-deductible donations Receipt/Acknowledgement letter Dave S
  - Dave was charged with creating a standard acknowledgment letter and receipt of tax deductible donations.
  - Dave wanted clarification regarding receiving charitable funds.
  - Jordan reports that we can receive charitable funds as long as the funds are solely for public services. Jordan confirmed this last November when he asked Municipal Regional Service Center via email. This was discussed in the November meetings and the email and question was saved.
- Create BARS codes for donation areas Jordon
  - The board acknowledges that bars codes will be needed to segregate funds and organize donations.
  - Tabled bars codes for now to discuss at a later date.
- Facilities Grant Selection and Next Steps
- 1. Billie and Stacey were tasked with getting clarification regarding the Tonasket Junior Baseball(TJB) application. The question was did the (TJB) need the TPRD grant considering it received an RCO grant \$250k. The short answer is yes. TPRD funds are needed for the improvements for the upcoming season. The RCO grant will not be accessible in time for this season. Billie and Stacey spoke with Shane Spangler and clarified the improvements needed for this season. Shane Spangler reported that most of the fields are unusable and need to be fixed prior to this season. Specific expenditures are in the TJB application. TJB received more complete quotes as part of a request by the board. Dave moves to approves the TJB

application for the TPRD grant for 5000 dollars. Rick Massey seconded. TJB application grant passes unanimously.

- 2.Next step is a writing up a contract and disbursement of the grant. Dave adds that a stipulation of receiving the grant should be that the recipient return to the board for a presentation of job completion report by a projected due date. Billie moves to have a subcommittee of Jordan and Stacey (alternate Dave and Billie as sub-alternate) create a contract with Megan for Junior Baseball. Rick seconded. The motion passed unanimously.
- 3. Stacey added in a written letter to the board. "It is my belief that TPRD should request/require the supplies for grant recipients be purchased within the taxing district when they (the supplies) are available and reasonable. If there are multiple options for purchasing within the district, I don't believe we should tell them which one to buy. It should be their choice. Jordan added that the TPRD grant application address this topic under the heading Selection Criteria. "**Keep it local:** Our consideration will be based on whether your project uses local businesses, local jobs, local contractors, and local resources".
- 4. Revision in eligibility criteria. Rewriting the grant application to change conflict of interest. Striking the original #3. Under the Eligibility criteria. Original #3. Family members of district commissioners and anyone the commissioners deem to pose a conflict of interest are ineligible for grant funding. Rewrite to #3 District commissioners will recuse themselves from voting on grant applications if they feel a conflict of interest exists. Dave moves to approve the revision as written above. Billie seconded. Revised #3 was approved unanimously.
- 5. Second running of TPRD grant. Due date for next application round of TPRD grant will be May 9th. Jordan and Rick will work on the press release. Billie moves to approve the second running of the grant, due date and press release. Dave seconded. Passed unanimously.
